

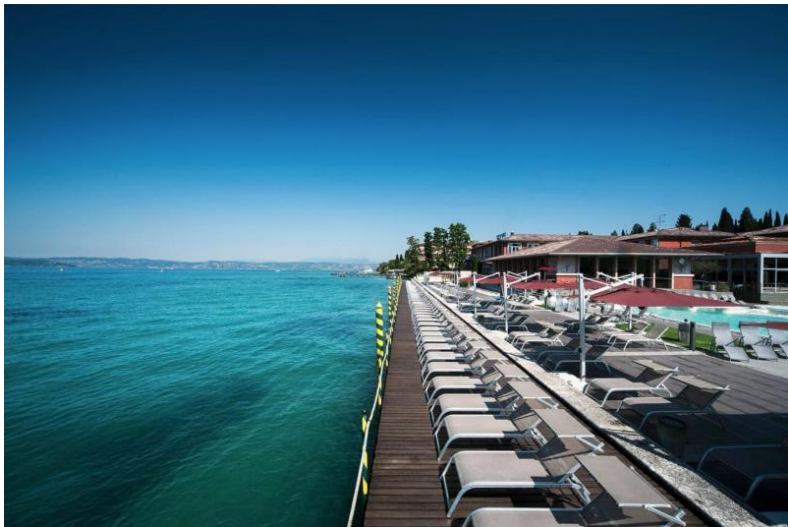

**Don't Be Alarmed!** Fire alarm testing will occur throughout the Cummings Center and Dunham Ridge campuses, Monday, April 24 through Wednesday, May 9, starting at approximately 6:30 AM. The schedule is as follows:

100 Cummings Center - Tuesday, April 24 through Friday, April 27  
500 Cummings Center - Monday, April 30 and Tuesday, May 1  
900 and 950 Cummings Center - Wednesday, May 2  
200 and 800 Cummings Center - Monday, May 7  
600 and 800 Cummings Center - Tuesday, May 8  
48 and 50 Dunham Ridge - Wednesday, May 9
